

### **POLICY 003 – CAMPER POLICY**

Campers, Fifth Wheels, and RVs (collectively, “campers”) are allowed in specifically designated areas only of the Polk County Fairgrounds during the Polk County Fair. All persons wishing to park and hook-up a camper must provide the following:

- 1) Sign and abide by FORM 003 - PCAS Camper Rules and Regulations Agreement
- 2) Provide payment in full by posted date
- 3) Provide proof of liability insurance covering the camper

Campers may also be allowed on the Polk County Fairgrounds with special permission from the Polk County Agricultural Society for other events. These campers must have written approval from the Polk County Agricultural Society, will be subject to rental fees, and must provide the documentation stipulated above. NO campers are allowed on the Polk County Fairgrounds without reservation.

As the owner/renter of this camper, I agree that this camper and anyone who makes use of it shall adhere to the following regulations. Any campers found to be operating outside of these regulations is subject to removal from the Polk County Fairgrounds:

- 1) Campers shall be leveled at all times. Campers shall be parked in such a way that does not impede vehicle or foot traffic throughout the camping area.
- 2) Camper owner/renters shall be required to provide proof of liability coverage for this camper.
- 3) All waste and sewage shall be disposed of properly, off-site, in accordance with local regulations. Please note that there is no sewage disposal site on the Polk County Fairgrounds.
- 4) The owner/renter of this camper takes full responsibility for protecting this camper against theft and non-approved usage.
- 5) The owner/renter of this camper takes full responsibility for this camper, its drivers, and any personal or property damages caused by this camper or its drivers.
- 6) No campers are allowed on the fairgrounds without a reservation.

#### **Guidelines Specific to Camping During the Polk County Fair**

Each camper hook-up is assigned a number. The reservation of specific hook-ups will be done during the current year's fair for the following year's fair. Payment for the following year's fair should be provided to the designated PCAS representative by the end of the current year's fair in order to reserve your camping hook-up. Camper reservation forms will be mailed out in the

June 4-H Newsletter, and can be found at polk-county-fair.com. Campers are not allowed on the Polk County Fairgrounds prior to the Sunday before the fair. All camper areas will be clearly marked.

*Polk County Agricultural Society [PCAS] and/or Polk County Fair [PCF] shall not be responsible for any damage to exhibits, animals, vehicles, merchandise, concession or any other personal property caused by any cause whatsoever. Additionally, fair visitors and participants waive and covenant not to sue and further agree to indemnify and hold harmless PCAS, and/or PCF from any and all claims, costs, causes of action (including reasonable attorneys' fees), relating to loss, injury or damages of any kind, while attending or participating in the Polk County Fair, to the fullest extent permitted by Nebraska law, including claims for negligence committed by the foregoing. Fair visitors and participants assume all risks and dangers associated with attendance or participation in the Fair.*
